Board of Directors Minutes

Regular Meeting April 15, 2015

Pursuant to the proper public notice, a Regular Meeting of the Board of Directors of Klamath County Fire District No. 1 was held at the Central Fire Station, 143 N Broad Street, Klamath Falls, OR 97601.

1. Call Meeting to Order

President Storey called the meeting to order at 7:00pm.

2. Pledge of Allegiance

President Storey led the Board and attendees in the Pledge of Allegiance.

3. Roll Call of Directors

Fire Chief Spradley took roll call of the Directors:

4. Approval of the Agenda

Chief Spradley amended the agenda to add item 8e. Quarterly Financial Analysis. Vice President Gourley made a motion to approve the amended agenda, seconded by Secretary-Treasurer Thomas, carried unanimously.

5. Public Comments

There were no public comments.

6. Public Hearing

a. Ordinance 14-01 Fees for Service

Vice President Gourley made a motion to read the Ordinance by title only, seconded by Secretary-Treasurer Thomas, carried unanimously. This is an Ordinance to establish the amount of certain fees charged by Klamath County Fire District No. 1 for various services including but not limited to Emergency Medical Response, Highway Assistance, Suppression Billing, FireMed, Standbys, Public Records, and Fire Prevention, and to provide the effective date hereof. Chief Spradley reviewed the proposed increased rates under the Emergency Medical Response section. There were no public comments.

7. Approval of Minutes

a. February 18th Regular Session Minutes

Vice President Gourley made a motion to approve the minutes, seconded by Secretary-Treasurer Thomas, carried unanimously.

8. Financial Reports

a. March 2015 Report

Phil Hull presented the monthly financial report. He gave a brief report on the status of switching the bank accounts over to US Bank. Phil continued through the report. Current Revenue is at 92.5% and Expenditures are at 74.1% at 75% of the way through the fiscal year. President Storey asked if the Fire District still anticipated receiving the budgeted amount for EMS Medical Revenue. Chief Spradley feels that the \$1.3 million budgeted is reachable. The Board also had a brief discussion on the overtime expenditures and budgeting for next fiscal year. After reviewing the rest of the financial report, Secretary-Treasurer Thomas made a motion to approve the March report, seconded by Vice President Gourley, carried unanimously

b. Ratification of February 2015 Bills

Vice President Gourley made a motion to ratify the February bills, seconded by Secretary-Treasurer Thomas, carried unanimously

c. Ratification of March 2015 Bills

Secretary-Treasurer Thomas made a motion to ratify the March bills, seconded by Vice President Gourley, carried unanimously

d. March EMS Billing Report

Chief Keady was not present at the meeting so Phil answered any questions that the Board had on the EMS Billing report. Vice President Gourley made a motion to approve the EMS Billing report, seconded by Secretary-Treasurer Thomas, carried unanimously

e. Quarterly Financial Report

Phil presented the quarterly financial report. The Board reviewed the actuals for the first 75% of the year and the projections for the last 25%. Vice President Gourley made a motion to accept the quarterly financial report, seconded by Secretary-Treasurer Thomas, carried unanimously

9. Old Business

a. Report on the Potential Levy

Chief Spradley reported that the Levy Project Team met earlier in the week. The team is still discussing what the Levy would consist of, but is coming closer on a decision. Chief Spradley reported that there is another meeting scheduled for Monday, May 4th. The Fire District is working with ZCS to look at Station 1 and the possibility of qualifing for a State Seismic Rehabilitation Grant for that station.

10. New Business

a. Review Proposed Budget Calendar

Chief Spradley confirmed that May 18th worked for the first meeting of the Budget Committee. A second meeting will be held on June 2nd if needed.

b. Appointment of Board Member to Captain's Examination Committee

Chief Spradley reported that the Captain's Eligibility List expired April 5th. The Fire District will be moving forward with holding a Captain's Examination and, due to contractual obligations, the Board will need to appoint a member to sit on the Examination Committee. Vice President Gourley agreed to serve on this committee, as he has in the past.

c. Appointment of Board Member to Insurance Committee

Secretary-Treasurer Thomas agreed to sit on the Insurance Committee. The Insurance Committee is scheduled to meet on April 28th at 1:00pm.

11. Informational Reports

Administration

a. March Web Site Statistics

The Board reviewed the monthly statistics. Chief Spradley reported that I.T. Specialist Celeste Aldinger has completely redone the web site and the new site went live on April 15th. Chief Spradley commented that it is a significant improvement over the previous site. He commended Celeste for all of her hard work on this project.

b. Thank You Letters Received

The Board reviewed the thank you letters received over the past month.

c. Fire Chief's Community Activity Memo

Chief Spradley reviewed his monthly activity memo. He gave updates on several of the items on the memo. He attended the swearing in for the new City Police Chief. This past month HR Answers was in town doing the onsite HR review. Chief Spradley also reported that the Fire District has worked with Assistance to Firefighter Grants to extend the Wellness and Fitness grant period of performance so that the Fire District can use some of the grant funds to cover for overtime while personnel attend the training.

d. Update on the Social Media Team

Chief Spradley reported that the Social Media Team has been working really hard to improve contact with the public and increase public awareness. There seems to be a positive response so far.

e. Other reports of the Fire Chief

Chief Spradley reported that the HazMat Team has worked with the City of Eugene to receive \$13,500 worth of radios through a grant at a cost of just over \$800 to the Fire District. The Wocus Station septic tank has had to be replaced over the past month. This was primarily due to the age of the system. Chief Spradley also reminded the Board that SDAO will be here the morning of April 28th for a two hour informational meeting. He encouraged the Board members to attend. President Storey asked about the status of filing the Operations Chief position. Chief Spradley reported that he has had several internal meetings regarding posting the job.

Operations

a. Incident Activity through March 31, 2015

Chief Spradley reported that the run volume is up about 11%.

Training/Ambulance

a. April Training Calendar

The Board reviewed the April Training Calendar. Chief Spradley pointed out the BNSF Crude Oil class that the Fire District hosted. Over 100 students participated in this training throughout the three days. Chief Spradley also reported on the Critical Stress Management classes that Chaplain Roberts helped to plan.

b. March Training Statistics

The Board reviewed the training statistics for the month of March.

c. Training Chief Community Activity Memo

Chief Spradley gave a brief report on training that personnel have recently attended. Chief Spradley reviewed Chief Keady's report. He provided updates on some upcoming training that will be paid for using grant funds.

Prevention

a. Fire Marshal Community Activity Memo

Chief Rice presented his monthly memo. He reported on several businesses that are either new to the area or have moved to new locations. Chief Rice is encouraging the crews to get in and look at these buildings as they have been remodeled and, even though they have the same footprint, they are completely different buildings on the inside.

12. Public Comment

There were no public comments.

13. Adjourn to Executive Session

Vice President Gourley made a motion to adjourn the Regular Board meeting, seconded by Secretary-Treasurer Thomas, carried unanimously. The Board adjourned to Executive Session at 8:33pm.
